Terms & Conditions

- This appointment is given on daily wage basis Panchkarma Masseur (Class-IV) on fixed wages of Rs. 375/- per day and other conditions of service will be governed by the relevant rules and orders of Govt. in force from time to time for daily wages working under Govt. of H.P.
- The post is purely temporary and may be terminated at any time by giving one month notice from either side viz the appointing authority/appointee.
- Appointee is entitled for 12 days casual leave and 2 days restricted leave during the year. He/She will be entitled for one day's casual leave after putting one month service and continuous wilful absence of appointee will be treated as unauthorized and services will be terminated without giving any notice. He/She shall not be entitled for Medical Re-imburement and LTC etc.
- The candidates have also to produce the medical fitness certificate from BMO/CMO of the concerned district. Women candidates pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidates will be re-examined for medical fitness after six weeks of confinement.
- The appointment carries with it the liability to serve in any part of Himachal Pradesh under the Ayush Vibhag.

The appointment will be further subject to the production of the following certificates/declaration:-

- Attested copies of educational qualification certificates.
- 06 months Diploma/Training Certificate in Panchkarma.
- Bonafide Himachal Certificate from the competent authority.
- Certificate of fitness from Medical Board of the concerned District Hospital.
- Taking an oath of allegiance/faithfulness to the constitution of India or making a solemn affirmation to that effect.
- Declaration to the effect that candidate shall not have more than one living spouse.
- Character Certificate.

If above terms & conditions are acceptable to the above named candidates, they may report for duty to the concerned District Ayush Officers, within 10 days from the receipt of this order, failing which it will be presumed that he/she is not interested in the post and offer of appointment shall be deemed cancelled. No further correspondence shall be entertained in this behalf. No TA/DA will be admissible for joining the post.
