NOTIFICATION

The Governor, Himachal Pradesh, is pleased to frame/notify the "Designation Scheme" for Ayurvedic Medical Officers of AYUSH VIBHAG on their deployment as Lecturer in various teaching faculties of Rajiv Gandhi Government Post Graduate Ayurvedic College & Hospital, Paprola, District Kangra with immediate effect subject to the following terms and conditions:-

1. The designation will be given only as per requirement of faculty as Lecturer in the concerned Department of R.G.G.P.G. Ayurvedic College & Hospital, Paprola, District Kangra, in terms of NCISM norms with respect to UG & PG courses.
2. The designation will be subject to fulfillment of minimum requirements of educational and other qualifications for the post of Lecturer as per the R&P Rules and NCISM norms.
3. The designation will not confer any right for any financial benefits or higher scale etc., and the concerned officer shall work in his own pay scale etc. Apart from this, this designation shall also not confer any right of seniority etc. on the post/cadre of Lecturer.
4. The procedure for giving the designation will be that the Principal, R.G.G.P.G. Ayurvedic College & Hospital, Paprola shall furnish the requirement of Lecturer for the purpose of fulfillment of NCISM norms to the Director AYUSH, H.P. who will call options from desirous and eligible AMOs having PG qualification in the concerned subject specialty by giving a wide publicity on the Departmental website. The willing AMOs shall have to exercise their option within 15 days from the publication of notice by return mail to the Department along with their credentials as per Annexure A of this Scheme. The Director Ayush will prepare panel of eligible AMOs based on the options exercised and their order of seniority in terms of joining the cadre of AMO. The senior most eligible and willing AMO recommended by the Director AYUSH, HP to Government for

designation as Lecturer will be considered and designated by the Government.

5. In the event of non acceptance of the offer of designation by the Ayurvedic Medical Officer concerned, his/her name will be excluded and next incumbent in the panel will be designated.
6. The AMO will be designated till the time requirement to fulfill the UG/PG norms as per NCISM by the Government.
7. The period of designation shall not confer any right upon the AMO for continuation/regularization as Lecturer and no experience shall be given to the incumbent other than the experience of working as AMO.
8. The Government will have the absolute right to relax any of the above mentioned conditions/norms fixed for designation in extreme exigencies and will have absolute right to designate any eligible AMO to the post of Lecturer in public interest.
