OFFICE ORDER

In supersession of previous guidelines / policy with regard to allowing BAMS/ BHMS interns of private educational institutions to undergo one year internship in Government Ayurvedic/Homoeopathic Institutions of the AYUSH Vibhag, Himachal Pradesh, a new "Internship Policy" to entertain the students pursuing BAMS & BHMS degree from private institutions situated within & outside the State for providing rotatory internship in Government Ayurvedic institutions of Himachal Pradesh duly approved by competent authority, is hereby framed as under:-

- 1. The objective of this policy is to facilitate desirous BAMS & BHMS (Bachelor of Ayurvedic / Homoeopathic Medicine and Surgery) interns from private AYUSH Colleges in Himachal Pradesh & Himachali students getting education outside the State to gain exposure to National Health Programmes, get orientated to various disease control and understanding of Ayurvedic healthcare delivery in the State of Himachal Pradesh.
- 2. Interested BAMS & BHMS interns from recognized private colleges within and outside Himachal Pradesh on completion of specified duration of their academic curriculum as determined by regulatory authority are eligible to be entertained in Ayurvedic/ Homoeopathic institutions for the purpose of internship.
- 3. The internship in Ayush institutions of the State shall be allowed to ensure meaningful exposure to National Health Programmes, Ayushman Bharat & other relevant health care schemes and institutional working in order to enhance their knowledge, practical skills.
- The number of seats for internship, maximum number of months, fee to be charged, competent 4. authority to allow internship are as below:-

- 5. No further extension in internship duration shall be granted.
- 6. In no case, direct request of BAMS interns of Private Colleges functioning within the State will be entertained. The request for internship shall be received only from the Director/ Dean/ Principal of the concerned Private Ayurvedic/ Homoeopathic College.
- 7. Interns shall be responsible for active participation in clinical activities, patients consultations, treatment planning and follow-up under the guidance of senior practitioner.
- 8. Upon completion of period of training, interns shall receive a certificate acknowledging their participation from the concerned In-charge of Institution .
- 9. The funds so collected as internship fees shall be deposited with Rogi Kalyan Samiti of the concerned hospital which will enhance and strengthen its resources. If there is no RKS in any hospital/ Dispensary, the fee collected shall be deposited in the dedicated account for that institution which shall be subsequent utilized for the purpose of strengthening.
- 10. Permission to undergo clinical training in Ayurvedic Institutions will be subject to fulfillment of following formalities:
 - i) Bonafide Himachali Certificate (not required in case of students of private colleges of HP).
 - ii) NOC from the parent college.
 - iii) NOC from parent University (no need in case of students of private colleges of HP).
 - iv) BAMS pass Certificate of 1st to 3rd professional annual examination.
 - v) Provisional registration certificate from Board of Ayurvedic & Unani systems of HP.
- 11 Required documents shall be deposited by the internship aspirants to the concerned District Ayush Officers/ Principal RGGPGAC Paprola/ MS (as applicable) who shall be considered for internship on first come first serve basis strictly. Further it should be ensured that the number of interns at a particular institutions should not exceed the maximum number as provided for in this policy. Further no extension or relaxation shall be admissible except with the prior approval of the Director AYUSH.

12. Any violation of this policy on part of functionaries of the Ayush Department shall make them liable for strict disciplinary action.
